This letter is in reference to your Permit to Install (PTI) application, identified as No. 13-19A, for a new automotive paint shop and modifications to an existing automotive assembly line at your facility located at 21500 Mound Road, Warren, Michigan (State Registration Number B2767).

The public comment period ended on August 19, 2019, and a public hearing was held on August 19, 2019. Written comments were received during the comment period. After careful consideration of the issues and pursuant to the delegation of authority from the Director of the Michigan Department of Environment, Great Lakes, and Energy (EGLE), I have approved PTI No. 13-19A. As a part of this approval, Air Quality Division (AQD) staff has revised and added conditions to the permit to address certain information received during the public participation process and the subsequent analysis of that information.

The AQD has prepared the enclosed Response to Comments Document (RTC), which provides our responses to comments received during the public comment period and at the public hearing. It also identifies the special conditions that have been modified and provides our rationale for modifying the special conditions. These changes are listed in Sections II and III of the RTC.

This approval is based upon and subject to compliance with all administrative rules of EGLE and conditions stipulated in the enclosed supplement. Please review these conditions thoroughly so that you may take the actions necessary to ensure compliance with all of these conditions.

The equipment covered by this permit is also subject to the requirements of the Renewable Operating Permit Program. Submittal of the M-001 and C-001 forms may be required prior to commencing operation. A change that is subject to Rule 215 subrules (1), (2), or (3), promulgated pursuant to Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, requires the submittal of the forms to the appropriate AQD District Office. If a change is made pursuant to Rule 216, please submit the required forms to the Warren District Office at the address provided in the M-001 form instructions. Also, you must notify the

Warren District Office, in writing, within 30 days after completion of the installation, construction, reconstruction, relocation, or modification of the process or process equipment covered by this PTI.

Additional information is included in the M-001 form instructions which are available on the Internet or can be obtained by contacting the Warren District Office at 586-753-3700. The AQD permit Web page is located at https://www.michigan.gov/air, click the "Permits" tab, and click the link at the first bullet entitled "Air Quality Division Permits."

Also, PTI No. 13-19 will be voided because the equipment is now covered by PTI No. 13-19A.
